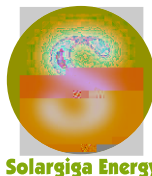

MAJOR TRANSACTION DISPOSAL OF STATE-OWNED LAND USE RIGHTS DELAY IN DESPATCH OF CIRCULAR
